INVITATION FOR BIDS

1. The Aamchowk Rural Municipality has allocated funds towards the cost of CONSTRUCTION OF AAMCHOWK RURAL MUNICIPALITY ADMINISTRATIVE BUILDING and intends to apply part of the funds to cover eligible payments under the Contract for CONSTRUCTION OF AAMCHOWK RURAL MUNICIPALITY ADMINISTRATIVE BUILDING (Contract No: ARM/NCB/WORKS/01/2079-80). Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Aamchowk Rural Municipality invites electronic bids from eligible bidders for the construction of CONSTRUCTION OF AAMCHOWK RURAL MUNICIPALITY ADMINISTRATIVE BUILDING under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
 Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: Rs.71531276.999
 - Minimum Work experience of similar size and nature: Rs.57226000
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Aamchowk Rural Municipality, Balankha, Bhojpur-Province One Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost Rs 5000 of bidding document in the Project's Rajaswa (revenue) account as specified below

6. Pre-bid meeting shall be held at Aamchowk Rural Municipality Balankha, Bhojpur Province One Nepal at 09-02-2023 14:00 hours.
7. Electronic bids must be submitted to the office Aamchowk Rural Municipality, Balankha, Bhojpur, Province One, Nepal through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 24-02-2023 12:00. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 24-02-2023 13:00 hours at the office of Aamchowk Rural Municipality Balankha, Bhojpur Province One Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 2692950 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
